2. CHAIRMAN & SECRETARY REPORT 2022/23

Clubs and Venues

We are thrilled to see a small resurgence in the dedication to our sport within our region. Clubs across New South Wales are making a conscious effort to reinstate Snooker and Billiards tables, and they're doing it with a strong commitment to providing high-quality conditions. These efforts are paramount in helping our up-and-coming players condition themselves to compete on a world-class level.

The passion and dedication of our clubs and players are truly commendable. By creating top playing environments, we are not only nurturing our local talent but also positioning ourselves to shine on the international stage. Venues like Mounties, Seven Hills RSL and St George Basin have been progressive in moving to Shender (or Shender top) tables. This has been evident with the staging of the WSF World Championships at Mounties earlier in the year.

Tournaments and Events

Snooker and Billiards NSW continues to shine with the staging of many events for our members. Between Snooker, Billiards, Women's and Junior events it is a real challenge to make room in our busy calendars, yet alone try to coordinate dates with other cue sports events i.e. Pool.

This year saw the staging of the WSF World Snooker Championship at Mounties which attracted close to 200 entrants from Australia and the World. Coupled with events like the WWS Australian Open, Bob Hawke AC Australian Open and a range of State Snooker and Billiards Championships, it has been an amazing year.

Government Relations and Funding

Snooker and Billiards NSW is a recognised State Sporting Organisation in NSW Government and is therefore eligible for annual funding. The amount of funding we have received (outside special grants) has been \$5,000 per year. This is barely enough to help keep the lights on. The new NSW Labour Government had made pre-election commitments to increase funding. This will require some additional work for us, and we will need to meet certain outcomes like increasing participation for Women as well as strengthening governance.

Within the guidelines of the new funding in future years, some of the outcomes the NSW Government is requiring are as follows but not limited to:





- 'Plan to increase female representation on the Board of the organisation to meet gender equity targets and to encourage affiliates to achieve the same' and;
- 'Plan to move to equal prizemoney for events where this is controlled by the organisation.'

Development Programs

Over the year we have been committed to coordinating various clinics for coaching and referee development. We will continue to build on the good work already with additional focus in the new year on programs for disability. We will aim to work with the ABSC body to align with various national programs and ensure NSW has representation on various sub-committees.

Our Partnerships

Our partnerships with clubs, sponsors, NSW Government, and other governing bodies in our Sport is critical for our success. The Board has been committed to strengthening these partnerships and will continue to be a key focus area for us. I see great opportunities in stronger alignment and collaboration with the ABSC and other State Associations. The opportunities to share ideas and resources is incredible, we just need people to be open minded and help make this happen.

A special call out to CL&S as the sponsor of record for the ABSC. Without their support Australia and NSW would not have the opportunity to experienced better playing conditions through the supply of equipment such as cloths and balls for our National and key State events. I would also like to thank all the NSW Clubs that have hosted and sponsored our events in the year. Thank you in particular to Mounties, Blacktown Workers, Club Marconi, Commercial Club Albury, Hornsby RSL, Guildford Leagues, Wentworthville Leagues, Central Coast Leagues and Gosford RSL.

Thanks must go to the great team we have on the Board and all the non-board members that have contributed through the year. You all know who you are and at the risk of missing names I will leave it at that. A big thank you team. Once again thank you for being an integral part of Snooker and Billiards NSW, and here's to the remarkable journey that awaits us! I look forward to working with you all in the new year.

5. COACHING AND JUNIOR DEVELOPMENT REPORT 2022/23

Coaching Development

We have held some more coaching accreditation clinics and increased our numbers for snooker coaches. 1 from ACT Canberra, 1 from Wollongong and 1 from Sydney. I am planning to hold another in November and will send the committee a draft as well an online accreditation for a new player in Coffs Harbour.

Activities & Initiatives

One of our coaches, Mark Harper has been busy with his students at school using the 4 foldaway tables at his school Seven Hills High. The students regularly use the tables and are having fun learning and playing. Mark also has a number of players he teaches that vary from 8 years old up to one lady over 70. He loves teaching and clearly has a gift for it.

Another coach Malcolm Winter has been visiting a retirement facility and providing some assistance to residents who thoroughly enjoy learning snooker skills.

I have submitted quite several coaching videos to Alex for review and to be posted on our website for reference to all our members and visitors.

Junior Development

Prior to the State U21 state titles, a coaching clinic was held at Blacktown Workers Club. A new first event player used this as an opportunity to gain some valuable skills. He was very grateful and vowed to continue seeking advice.

I can confirm that one of our best Juniors, Zac Hilton will be going to China at the end of October to attend the International Snooker academy in Yushan. Zak is going for 1 month and will no doubt gain some wonderful knowledge and improve his skills.

Activities & Initiatives

I am in talks with a lady who has up to 20 exchange students from China who would like to have a coaching and a friendly competition day in the January school holidays. Their ages are from 10 to 18. I have mentioned it to Seven Hills RSL, who have asked for a proposal with details of the day and look forward to hosting it. More details to follow...

6. BILLIARDS REPORT 2022/23





2023 was our first year post-covid that did not have overhanging events and was more or less a normal year, except that the Minici/Pearson duopoly was finally broken after a decade of sharing the lollies between them. In the final event of 2022 we saw Roger Farebrother, perennial semi-finalist breakthrough for a maiden win in the State Major Timed event at Hornsby RSL, against an under-prepared Michael Pearson. While Michael looked below his spectacular best Roger rose to the occasion playing solid scoring billiards. Roger held his nerve to lift the Les Hayes Cup by a margin of 500-449

Continuing the roll call of semi-finalists that almost get there Andy De Haan finally put his hands on the Keith Lord Cup, the oldest trophy in our cabinet for the State Minors Billiards (timed). This storied trophy contains the names of every great Billiards players in NSW since 1956. You can only win it once so there are 67 names that will live on in the annals of top-level billiards in this state. This was Andy's fourth final and he was wondering if he would ever get there. Dirk Hellenbroich pushed him all the way in what was a tense and close final, 321-299

At the same venue Central Coast Leagues Club we also hosted the Ladies State Minor Billiards won by a returning superstar of cue sports Tanya Harrison over Monica Brettle, both ladies in their first state level billiards final, 101-66.

Tanya went on to prove that this was no fluke by taking out the Minor/Major double in her first year of return to competitive play, defeating Kenny Chandra in the final. It was Kenny's first Billiards event and only Tanya's second, a testament to how the game is growing in popularity for women.

Joe Minici won the sports blue riband event, the State Major (timed) at Blacktown Worker's Club. This was his fifteenth win in this event. The win means he has won this event at least once in every decade for the last five decades, his first win coming in 1989. An achievement unequalled in any sport in NSW and possibly Australia. He defeated Hassan Kerde who en route to the final knocked off the other entrenched finalist Michael Pearson.

Guildford Leagues Club once again hosted the State Minor Point Score event. In an uncharacteristic display of consistency Peter Tankard entered the event as top seed, finished the





round robin in first place and won the final against the best player yet to win a state title Gene Crossingham. It's a matter of when, not if, for Gene who is always thereabouts at the pointy end of billiards tournaments. In winning Peter has now completed the double of the Minor events, the fourth player to do so and joins the elite company of Ron Tulloch, George Chammas and Adwin Teh.

The final state level event for 2023 was the Major Point Score event, sponsored by STM Trucks and Machinery at Club Marconi. It produced one of the most remarkable sights in Billiards; both Joe Minici and Michael Pearson watching the final from the bleachers. It is the first time Michael has failed to reach the final since the inception of this event. The winner Todd Hayward claimed his first major State Title and he did it the hard way, defeating three official Legends of NSW cue sports; Mike Pearson in the quarters, Joe Minici in the semis and defending champion Roger Farebrother in the final 401-349.

We now look forward to our international event the Sydney Open Billiards at Club Marconi on the first weekend of November. World number 1 Peter Gilchrist has confirmed his attendance and we expect he will once again show us that despite our best efforts we still have a lot to learn.

Billiards in NSW is flourishing and growing each year, with both men and women enjoying the competition and the social side of the game. There is a real fraternity amongst billiards players which does not exist in other cue sports with players helping each other to become their best while sharing banter and a laugh afterwards, or even during the games.

Special thanks to our Champion TD Steve Cowie without whom none of this would be possible. It's not a real tournament unless Steve shouts "You're on the clock"

7. TREASURER'S REPORT 2022/23

Presented by Alex Render for AGM 4/12/2023

I am pleased to provide the Annual Financial Statements and summary report for the period 1/7/2022 - 30/06/2023.

Supporting this summary report is the profit and loss statement and balance sheet organised by Snooker and Billiards NSW Inc. Detailed event breakdowns can be supplied at the request of any financial member at any time.

NSW has seen some good growth in the year with new members joining and competing in our events. Membership revenue in the financial year was lower than projected due to extended memberships from the Covid-19 period. Membership fees for full members was increased to \$60 for next financial year and we expect revenue for membership to normalize over \$10,000 per year. The Board introduced merchandise sales in the year which saw new expenses of approximately \$5,000 which has been close to recovered through shirt (polo) sales. We still hold stock on hand and expect to make a small profit from merchandise sales.

The Board has found the use of online selling working well and intends to expand online sales to other merchandise in the future. Snooker and Billiards NSW continues to work with NSW Government to secure grant funding. In the financial year we received our standard \$5,000 grant payment which was expended in full on operational costs such as insurances, subscriptions, website hosting and referee development. This year saw Labour return into NSW Government and the State Budget is expecting to invest more into NSW Sport in the following 3 financial years. Subject to meeting criteria and compliance, we are in a good position to secure additional annual funding in FY23- 24 onwards.

The preparation of the financial statements is supported by an annual review of the accounts which was prepared by Dennis Wong. An associated letter is attached to this report.

9. NSW REFEREES REPORT 2022/23

Presented by Gay Knight for AGM 4/12/2023

Members, I'm pleased to present my fourth annual report as your State Director of Referees, which covers the financial year ending 30/06/23.

Firstly, it was extremely pleasing for all that Covid-19 did not have the impact upon our lives as in recent years, enabling the Board to plan and schedule a full calendar of events and activities for our Sport which were able to be successfully held throughout the year. This included at least 32 events (WSF, APSBF, National, State) – and one main reason each of those events was successful is because of the important support and assistance provided by the NSW Referees involved.

Collectively, a total of just 18 (33%) of our NSW Referees regularly put their hands up and made themselves available to officiate during these 32 events. However, this overall participation rate is extremely low and clearly demonstrates how our Sport is currently reliant upon the services of a committed and enthusiastic few who are willing to regularly apply themselves to the role of Referee and assist organisers to stage such events successfully. Whether at the various local Sydney venues, or travelling interstate, or perhaps internationally, I once again extend my sincere gratitude to every one of those 18 Referees for providing their time and passionate response to events staged during 2022/23.




New accreditations obtained during 2022/23 training workshops totalled 10 which is a pleasing result, and there are still a few candidates who deferred their assessments for personal reasons. However, these were offset by the loss of 5 existing Referees primarily for health-related issues and no longer being interested. This is further compounded by others dealing with severe medical and age-related restrictions which will likely see their retirement






during next financial year. The total number of NSW certified referees as at 30/06/23 was 54 (including ACT). A breakdown of this number by Region is provided below:











Initial response to strategies devised in the post-Covid period at increasing our certified referees has been very positive to date. Four separate training workshops have now been conducted utilizing our own self-developed program, which continues to be updated and tweaked as we proceed.

Two referee training workshops were conducted during 2022/23. One at Ramsgate RSL in Nov-Dec 2022 for six candidates, with four successfully obtaining their Class 3 Snooker & Billiards certification, with the other two not completing the course. The second workshop at Club Forster in May 2023 for eight candidates was not as successful, with one not completing the course, four failing their assessment and three deferring their assessment for personal reasons.

A total of 25 candidates have now attended our training workshops with each providing very positive feedback on the overall format and program content. We are receiving a good response to the SBNSW website "Expression of Interest in Becoming a Referee" online option, and it is generating a steady stream of contacts for our ideal goal of one training workshop every six months. Importantly, these workshops represent the first formalised and coordinated Referee training activity conducted by SBNSW in the Sydney area for many,





many years. On that basis alone, the steps taken to date by the Board and training facilitators can be regarded as successful and a sound platform upon which to build further.

Training workshops will continue to be planned and organised subject to the level of Expressions of Interest and enquiries received through the SBNSW website or by contacting the State Director of Referees.

Highlights for 2022/23:

Congratulations to Gareth King, who received his upgrade to Class 2 in September 2022 and promptly celebrated by officiating the Final of the South Pacific Open Snooker later that same afternoon. But three weeks later it was to get even better still, when Gareth was selected to control his very first Bob Hawke Australian Open Snooker Final. *Well done, Jim!*



Congratulations to new Referees Greg Aghayan (Class 3 Snooker & Billiards) and Patrick Gauci (Class 3 Snooker) who graduated from the training workshop conducted at Hornsby RSL, with their assessments completed in August/September 2022. *Welcome aboard*.

Tim Hilton and Kelvyn Marshall are also to be congratulated. Both have demonstrated a great deal of passion and commitment towards the role since obtaining their Class 3

Congratulations to those five: David Battersby, Gareth King, Gary Knight, Kelvyn Marshall, and Trevor Webber.









MINUTES OF 105th ANNUAL GENERAL MEETING

Venue: Held virtually via Microsoft Teams

Date: Monday 4 December 2023

1.0 OFFICIAL WELCOME

1.1 Chairperson Alex Render officially welcomed all members present.

This was followed by a moment's silence for members who had passed away during the past 12 months.

1.2 ATTENDANCE: Present:

- IN PERSON: Alex Render, Carlie Tait, David Waller, Peter Quinlivan, Don Stewart, and David Jackson
- (b) VIRTUALLY: Peter Tankard, Greg Jenkins, Gary Knight, Gareth King, Jason Hastings, Glen Wilkinson, Tony Vuong, David McMahon, Paul Davies, David Walsh, and Mick Sharp
- (c) PHONE: None

The total number of members in attendance at the meeting was 17 as per the attendance register.

- 1.3 Chairperson Alex Render confirmed that the required quorum was present and formally opened the meeting at 6:34pm.
- 1.4 The notice of meeting dated 15/10/23 convening the AGM was taken as read.

2.0 APOLOGIES

- There were no formal apologies received.
- 2.2 Any further apologies were then called for: Patrick Gauci and Andy De Haan were received.

RESOLVED: That apologies be accepted. (Proposed Dave Waller and seconded Carlie Tait).





3.0 MINUTES OF PREVIOUS MEETING

- 3.1 Chairperson Alex Render advised that the minutes of the previous AGM held on 24 November 2022 were circulated to members via email, together with the current Notice of Meeting.
- 3.2 Matters arising: Nil
- 3.3 The Chairperson sought a resolution that the minutes be confirmed and adopted.

RESOLVED: That the minutes of the previous AGM, dated 24/11/22 and circulated by email be confirmed, and signed as a true record of that meeting. (Proposed Carlie Tait and seconded David Waller)

4.0 CHAIRMAN'S ANNUAL REPORT

4.1 Chairperson Alex Render presented his report on behalf of the Board of Snooker & Billiards NSW Inc. (SBNSW) for the Financial Year ended 30/06/23 – copy is attached.

The main points highlighted include:

- a) Great membership and participation the snooker and billiards community in NSW has grown by almost 15% in the past year, showing excellent member and club participation. We will introduce a social membership category in the new year.
- b) Clubs and venues Clubs in NSW are experiencing a resurgence in snooker and billiards with efforts to reinstate tables. Particular mention of Mounties, Seven Hills RSL, and St George Basin who adopted Shender tables and hosted events like the WSF World Championships.
- c) Tournaments and events NSW organised numerous events, including the WSF World Snooker Championship at Mounties with nearly 200 participants, as well as the WWS Australian Open, Bob Hawke AC Australian Open, and State Snooker and Billiards Championships making it a great year, despite some calendar coordination challenges with other cue sports events.
- d) Government funding SBNSW currently receives minimal annual funding of \$5,000, prompting the need for additional efforts to secure increased funding from the NSW Government in the new year. Alex noted funding is contingent on meeting outcomes such as enhancing women's participation and delivery of other initiatives.
- Development programs Continued commitment to coordinating coaching and referee development clinics and in the coming year expanding programs for disability inclusion and collaborating with the Australian Billiards and Snooker Council (ABSC) to align with national initiatives and secure representation on diverse sub-committees in NSW.
- Alex concluded by thanking everyone for their support, particularly the 6 Directors who worked tirelessly.
- 4.2 There were no questions arising.





RESOLVED: That the Chairman's Annual Report, as read and tabled, be received and adopted (Proposed David Waller and seconded Mick Sharp).

5.0 FINANCIAL REPORT

- 5.1 The financial statements of account for SBNSW covering the 12-month period ending 30/06/23 (refer to attached) were not tabled but copies were made available on the website. The Chairperson advised that a copy is also readily available to financial members upon request.
- 5.2 The Chairperson also confirmed that the accounts of SBNSW had been examined, and the correctness of the profit and loss accounts and balance sheets ascertained, by an auditor after the financial year as required in the SBNSW Constitution. SBNSW's usual accountant (Dennis Wong) was utilised for this purpose. Please note that a full audit of SBNSW's financial accounts is not required under the Associations Incorporations Act 2009 (NSW).
- 5.3 The Chairperson, Alex Render mentioned that the year-end has seen COVID concessions come to an end with all grants expended and acquitted. There was also mention of increased revenue from rising memberships.
- 5.4 Peter Tankard questioned whether the \$125 surplus was perhaps marginal but the Chairman responded that the finances of SBNSW were healthy with further good prospects of funding increases for next year.

RESOLVED: That the financial report, as tabled, be received and adopted. (Proposed Greg Jenkins and seconded David Waller).

6.0 DIRECTOR'S HONORARIUMS

- 6.1 The option for payment of an annual honorarium to Board members was again considered as allowed for in the Constitution. It was noted that honorariums were consistent with:
 - Legal advice obtained by SBNSW at that time was that honorariums would fall within the terms of the Associations Incorporation Act 2009 (NSW).
 - b) Wording contained within Clause 20.4 of the Constitution that does not preclude the payment of honorariums, as the wording at the start is "except as prescribed in this Constitution", and
 - Clause 20.5 clearly deals with payments to members in good faith subject to the conditions in that Clause being met.
- 6.2 It was then proposed that payment of an honorarium to SBNSW Board members was warranted given the significant amount of time and responsibility necessary to effectively fulfill their role as Directors during their elected term.
- 6.3 All current Board members then left the room, and the remaining members discussed the matter further. It was proposed and seconded that an amount of \$800 to each Board member would continue and was a reasonable recompense in recognition of their valuable contributions. The motion was voted unanimously in favour with no objections.





6.4 A further question arose from Peter Tankard if the financials would cover the cost of honorariums? The Chairman responded yes, noting again the good prospects of funding increases for next year.

RESOLVED: That an honorarium of \$800 is to be paid, as last year, to all existing SBNSW

Board members, with payment effective at the close of this AGM. (Proposed Alex
Render and seconded Peter Quinlivan).

7.0 SPECIAL RESOLUTIONS

7.1 A Special Resolution was presented by the Board to make minor changes to the Constitution in accordance clause 23.1 to clarify membership periods and renewal dates. The proposed special resolution was accepted by the meeting. The Constitution will be amended accordingly and published in due course. Details of this special resolution can be found at https://www.snookernsw.com/agm-2023.

RESOLVED: The proposed special resolution was accepted to make minor changes to the Constitution in accordance with clause 23.1 to clarify membership periods and renewal dates. (Proposed Carlie Tait and seconded Peter Tankard).

8.0 ORDINARY RESOLUTIONS

8.1 There were no Ordinary Resolutions presented by the Board.

9.0 ELECTION OF BOARD OF DIRECTORS for 2023/24

- Chairperson Alex Render asked Carlie Tait to act as Returning Officer for 2023/24 election.
- 9.2 Carlie confirmed that the current Board will remain in their elected positions until the close of this AGM. She also referred to the previously issued formal Notice regarding Call for Board Nominations and the process involved.
- 9.3 Carlie advised that there were seven (7) Directors to be elected and SBNSW had received nine (9) valid nominations that were returned in terms of stipulated requirements. Carlie noted that Clause 11.2(a) of the Constitution provides for a maximum of seven (7) Directors to be elected annually. Following a vote from members in attendance the following were duly elected as Directors, in accordance with Clause 12 of the Constitution: Alex Render, David Waller, Carlie Tait, Greg Jenkins, Peter Tankard, David McMahon, and Todd Hayward. In addition to the seven (7) elected Directors, the Board may appoint up to two (2) Appointed Directors. Members who believe they had the necessary skills and attributes to make a positive contribution as an Appointed Director with the SBNSW Board were urged to contact alex.render@bsansw.com to discuss the matter further.





- 9.4 In terms of adopted guidelines, Carlie advised that immediately following the conclusion of this AGM the seven (7) newly elected Directors shall convene a private Board Meeting to elect a Chairperson and Deputy for 2023/24.
- 9.7 Acting Chairperson, Alex Render then resumed control of the meeting.

10.0 APPOINTMENT OF PUBLIC OFFICER

10.1 Acting Chairperson Alex Render that Peter Quinlivan was to undertake the position of Public Officer for 2023/24. Confirmation of this appointment was noted and confirmed by the meeting.

RESOLVED: The appointment of Peter Quinlivan as Public Officer was confirmed. (Proposed David Waller and seconded Greg Jenkins).

11.0 APPOINTMENT OF PATRON(S) FOR 2022/23

11.1 David Jackson and Don Stewart will continue as co-patrons of Snooker & Billiards NSW.

RESOLVED: The appointment of co-patrons David Jackson and Don Stewart was confirmed.

(Proposed David Waller and seconded Peter Quinlivan).

12.0 NOMINATION(S) FOR LIFE MEMBERSHIP

12.1 A motion was received to nominate Glen Wilkinson and David Waller as life members. The nomination was read by David Jackson to illustrate the long contribution to snooker and billiards in NSW made by each of these gentlemen. The Board confirmed their recommendation of support for the nominations. In accordance with Clause 4.17 of the Constitution, both Glen Wilkinson and David Waller were elected by the members present at the AGM. The Board extended their congratulations and gratitude to both Glen and David for their outstanding achievements and service over many years.

13.0 SPECIAL BUSINESS

13.1 There was no special business put forward by the Board for consideration.





14.0 CLOSE OF MEETING

- 14.1 Acting Chairperson, Alex Render thanked his fellow Directors for their support and dedication over the past year. He also extended his congratulations to each on their reelection to the Board and wished them every success for SBNSW's upcoming year.



Overall, how would you rate the event?
















